(California state law requires embalming or refrigeration of deceased if held for more than 24 hours after time of death.)

## DIRECT CREMATION

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers and other cremation containers, including containers made of wood, containers made of fiberboard and containers made of other composite materials. We offer a selection of cremation oriented caskets.

Our charges for direct cremation (without ceremony) include minimum services of funeral director and administrative staff, transportation of deceased from place of death to funeral home, transportation to the crematory, crematory fee and refrigeration.
